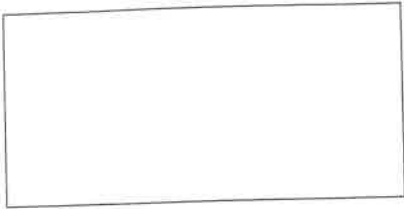

y is the bid price in Rand excluding value added tax (VAT)
