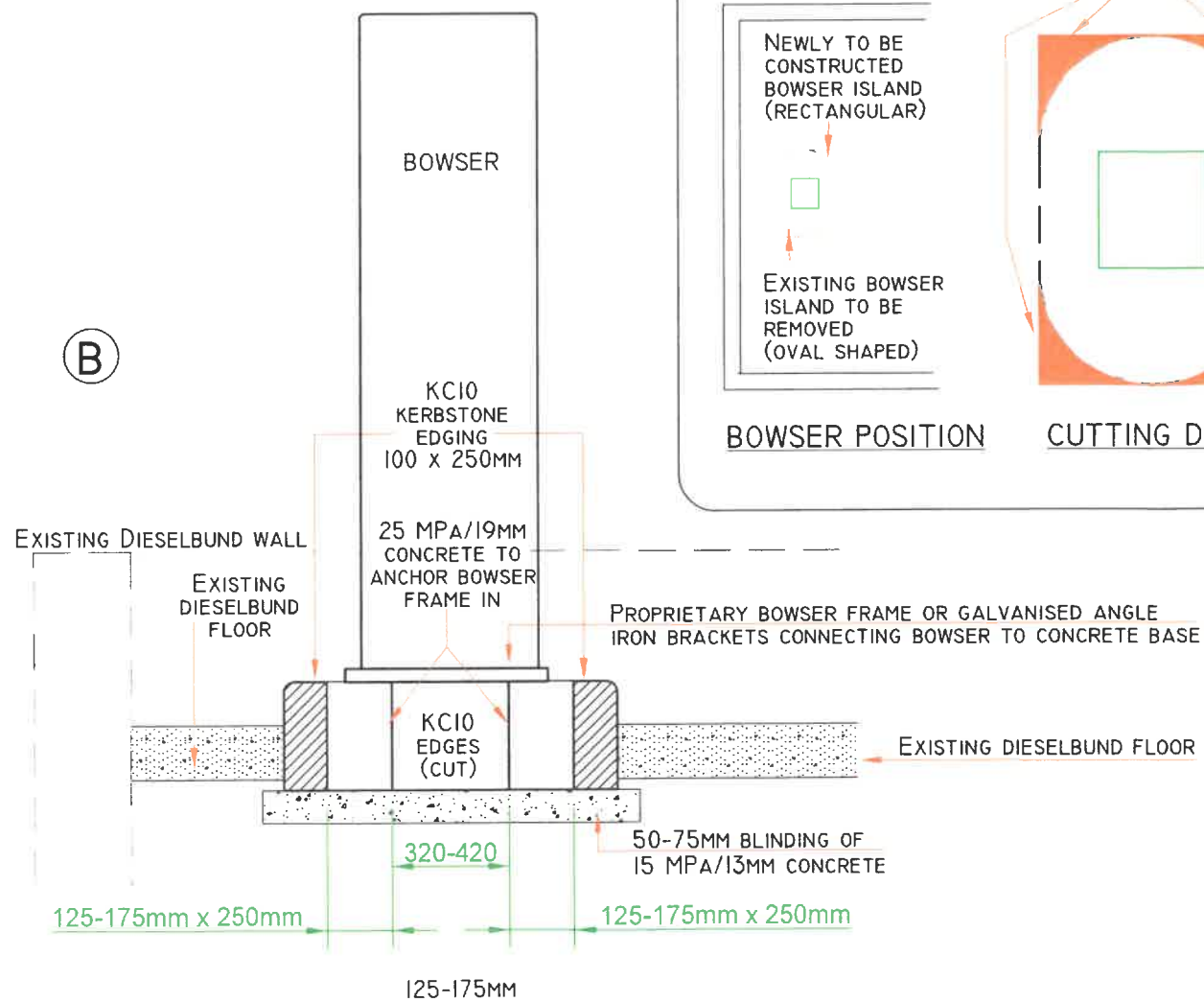

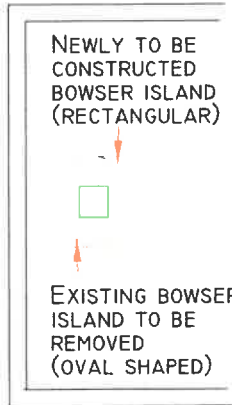

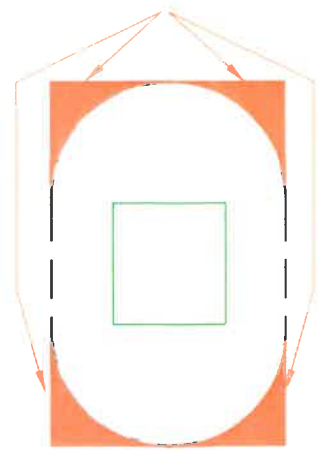
SECTION FOR NEW BOWSER AND ISLAND

CUT OUT RED AREAS FROM THE DIESELBUND FLOOR AT STRAIGHT ANGLES



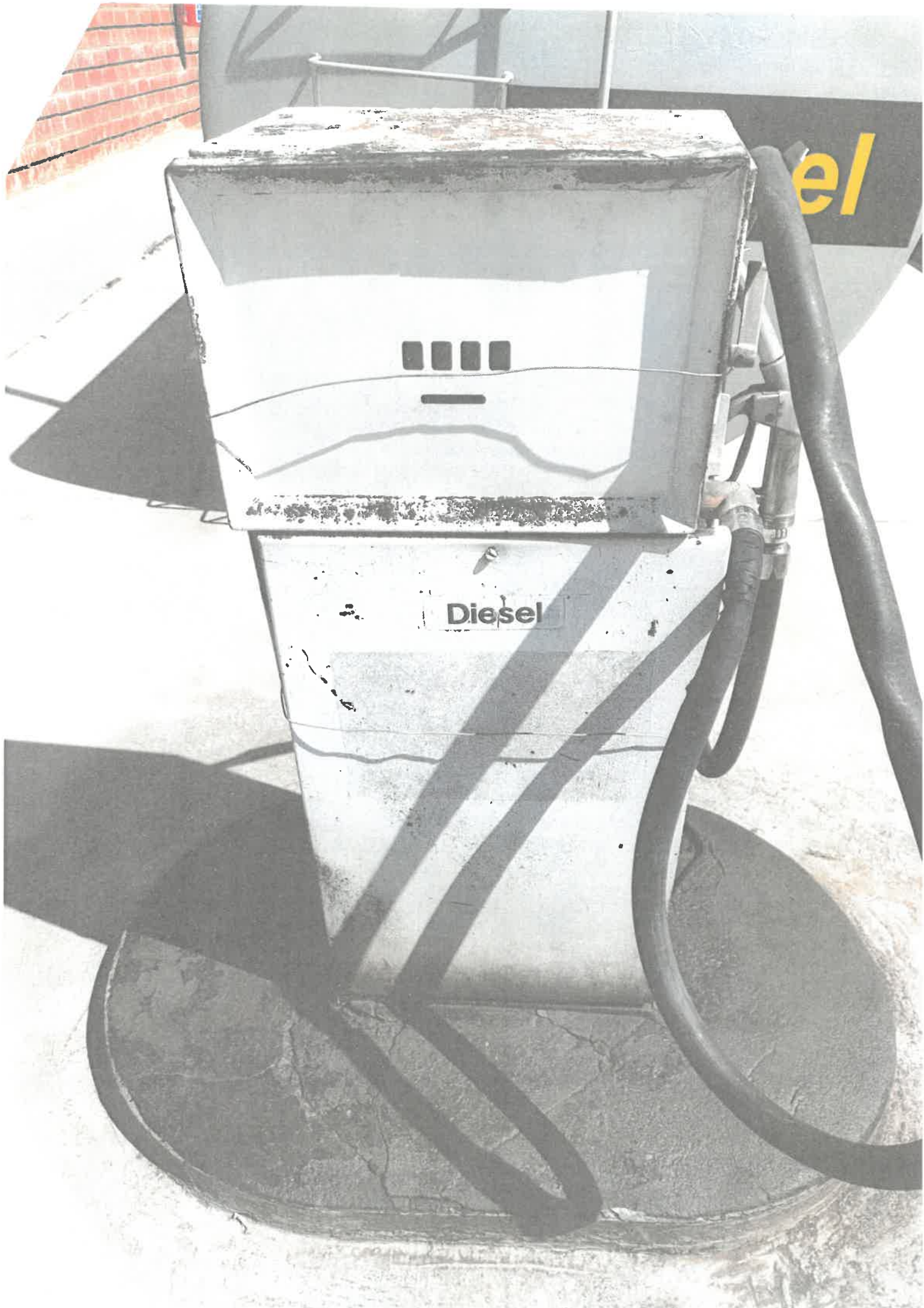
BOWSER POSITION
