Umphakathi ohlala kuleli pulazi kuthiwa usuhlukene phakathi kwazise kukhona abahambisana nekomiti elisha okuthiwa likhethwe ngokungemthetho nelidala elikhishwe isikhathi singakafiki.

Kuthiwa kunamalungu omphakathi antshontsha izinkomo maqede azidayisele abanikazi bamapulazi angomakhelwane.

Kusolwa uSihlalo wekomiti elisha, uMnu Jabulani Buthelezi, okuthiwa uhamba phambili kulesi senzo.

Abahlaseli kuthiwa kabamtholanga uNkz Khumalo kwazise ubengena ebusuku emsebenzini.

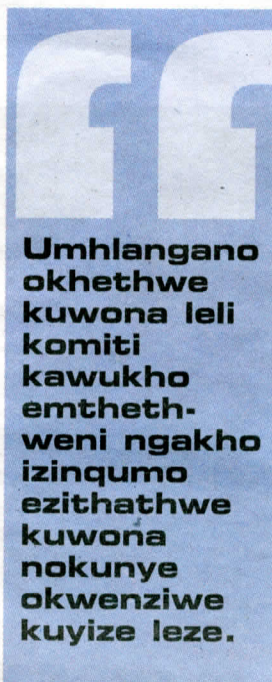

Leli komiti likhethwe eminyakeni emibili edlule kodwa lize labhaliswa kulo nyaka ngokusemthethweni.

Ummeli kaNkz Khumalo uMnu Lourens de Klerk, ubhalele umnyango ewazisa ukuthi ukukhethwa kwaleli komiti elibhaliswe ngenyanga edlule ukuthi lisha kakukho emthethweni.

Leli komiti eliholwa nguMnu Jabulani Buthelezi kuthiwa lakhethwa ngowezi-2013 kwathiwa ngelesikhshana, ekubeni elidala lingakasiqedi isikhathi salo.

UMnu de Klerk ucaphune umthetho-sisekelo wale trust, kwizigaba eziphikisana nalokhu okwenziwe yisikhulu somnyango (ILANGA LangeSonto elinalo igama laso). Uthi umthetho-

sisekelo ukubeka ngokusobala ukuthi ikomiti likhishwa ngemuva kweminyaka emihlanu.

Kuthiwa uma lizokhishwa kumele laziswe kusasele izinsuku ezingama-21 ngaphambi kokuba kuhlale umhlangano, ukuthi kuzodingidwa udaba lokuba lisuswe kufakwe elisha. Futhi lokhu kuthiwa kumele kwenziwe kube yisiphakamiso sokuthi lizokhishwa, kungamane nje libhozomelwe.

Kulo mthetho-sisekelo ILANGA LangeSonto elinayo ikhophi yawo, kuthiwa lelo komiti elikhishwayo kumele linikezwe ithuba lokwenza umbiko maqondana nokusebenza kwe-trust, kufundwe nezitatimende ezichaza ukungena nokuphuma kwezimali.

Umhlangano kuthiwa kawuvele ubizwe nje kodwa kumele ulungiselelwe kusasele izinyanga ezintathu ngaphambi kokuphela konyaka walo wezimali.

Kakunoma wubani oyobiza umhlangano wokuba kukhethwe.

Kuvula nokuthi yizindlalifa (beneficiaries) kuphela ezinelungelo lokuvota uma sekumhlangano waminyaka yonke.

## INCWADI YOMMELI

Ummeli uthi ikomiti elidala likhethwe ngoZibandlala (December) wezi-2008, ngakho iminyaka emihlanu ibingakapheli njengoba selisuswa esikhundleni.

Encwadini ayibhale ngowe-2013, lo okukhethwe ngawo, eyiqondise kumnyango, ukuvezile ukuthi izikhulu zawo bekungamele zibize umhlangano ngoba kazinalo ilungelo lokwenza lokhu ngoba akalona ilungu le-trust.

Umhlangano kuthiwa kumele

ubizwe ngusihlalo noma yiphini lakhe abanelungelo lokuvotisa.

Uma sekuvotwa kuthiwa kakumele kuphakanyiswe izandla okwezingane esikoleni, kodwa indlalifa ngayinye kumele iye egunjini lokuvota ifike ibhale khona ivoti layo.

UMnu de Klerk encwadini ayithumelele umnyango uthi umhlangano okukhethwe kuwona leli komiti kawukho emthethweni, ngakho izinqumo ezathathwe kuwona nokunye okwenziwe kuyize leze.

Kule ncwadi yakhe uphinde waveza ukuthi uMnu Jabulani Buthelezi, ongunsihlalo wekomiti elisha, akasiyona indlalifa kodwa ngamalungu omndeni wakhe ayizona, ngakho akanalo ilungelo lokuba angakhethwa ahole le trust.

Uthi futhi ukweleta i-trust u-R61 200, ngakho kakukwazi nangengozi ukuthi angaba ngusihlalo. UMnu Siphelele Khumalo oyiphini likaSihlalo, uMnu Abel Khumalo onguMgcinimafa, uMnu Mthembu nowakwakhe uMaShezi abangamalungu engeziwe, kabazona izindlalifa futhi kabaveli ohlwini lwabafaka isicelo somhlaba, ngakho kabakulungele ukuba bakhethwe ezikhundleni.

UMnu Buthelezi uthi yena ayindlalifa ngokuphelele kwazise amalungu omndeni wakhe ahlala khona kuleli pulazi. Uthi kakukho mali ayikweleta i-trust, ungene ehlathini laleli pulazi wagawula izingodo wazidayisa ngakho udinga iziliphu ezicacisa ukuthi ukweleta bani.

Uthi wumnyango owabatshela ukuthi makukhethwe ikomiti elisha ngoba elidala kalenzi lutho.

Uvumile ukuthi inkosi ilihlakazile ikomiti labo nokuthi kunezinkomo abazidayisele umnikazi welinye lamapulazi eVryheid kodwa zagcina sezilandwa ngoba kukhona abathi zebuwe.
