AMENDMENT TO REVENUE TARIFF 2022/23: VOTE 3 (ACADEMIC FEES)

The Department of Agriculture and Rural Development initially submitted the revenue tariffs for 2022/23 to Provincial Treasury for approval in December 2021, but that submission excluded revisions to the academic fees generated from both agricultural colleges (Cedara Agricultural College and Owen Sithole College of Agriculture) of the department. These fees were excluded at the time because these colleges were supposed to move to the National Department of Higher Education and Training (DHET) in the 2022/23 MTEF budget process.

It was subsequently decided that the function shift of agricultural colleges to DHET will be postponed, meaning that these colleges remain under the Department of Agriculture and Rural Development for the time being. As such, the department reviewed its revenue tariffs relating to the academic fees associated with these two agricultural colleges and have submitted these revisions to Provincial Treasury for approval.

Consequently, Provincial Treasury has carefully considered your request to amend the 2022/23 tariff structure as per your submission dated 09 June 2022.

The proposed tariff structure amendment is hereby approved in terms of Treasury Regulation 7.3.1.

Kindly factor the effect of this approval into your revenue projections for the IYM and Revenue IYM for 2022/23.
