

ANNUAL REPORT TO CITIZENS: 2015/16 FINANCIAL YEAR

1. Who We Are...

We are the KwaZulu Natal Department of Agriculture and Rural Development in the Province of KwaZulu-Natal and we have the following Vision and Mission:

Vision: "A united, sustainable and vibrant agricultural sector with thriving rural communities in balance with nature.

Mission: "To promote, through partnerships, sound agricultural practices that stimulate economic growth, food security and advancement of rural communities in KwaZulu-Natal."

2. What we do...

The KwaZulu-Natal Department of Agriculture and Rural Development has the following overall main services:

- * Crop production, livestock farming, aquaculture, natural resource use and management and land reform (a national competency but supported by the Department at provincial level), extension and care and agricultural research.
- * Veterinary disease control, prevention of zoonotic diseases, inspection services and primary health care services.


The KwaZulu-Natal Department of Agriculture and Rural Development has also the following strategic goals:

3. Who is in charge ...

The MEC for Agriculture and Rural Development is Honourable Mr. T. Mthembu. He is accountable for directing the KwaZulu-Natal Department of Agriculture and Rural Development activities in line with the National and KwaZulu-Natal Provincial Government's priorities.

The Head of Department is Dr. S.F. Mkhize, a public servant appointed to ensure that the Department efficiently implements the Executing Authorities policies and directives.

RESULTS ACHIEVED ON PROGRAMMES

Programme 2 : Agricultural Development

- * The Department has established 122 Communal Estates, 198 tractors transferred to farmers of communal estates.
- * Department planted 4258 ha of beans and 5608 ha maize.
- * Through River valley Projects the Department planted 159 ha of vegetables which were less than anticipated due to drought.
- On infrastructure Projects the Department implemented 75 dams at the cost of R26 million. Out of 75 dams, 12 dams are already completed. The Department also established dip tanks and boreholes across the Province. A total of 6 piggery and 8 poultry projects were completed.
- * Makhathini Development Projects the Department implemented the following projects:
 - Irrigation Canal R2 million.
 - Surface Drainage Scheme R24 million
 - * Rehabilitation of Balamhlanga Pan R11.5 million
 - Expansion of Makhathini Irrigation Scheme R2 million
 - * Development of Nondabuya/Kwela Irrigation R2 million
 - * Development of Skhakha irrigation R5 milllion
 - Development of Mbangweni R1 million
- * 679 Farmers were trained on Agricultural programme in the financial year.

- * Partnership (MOU) with Education for funding 5 schools ((Weston, James Nxumalo, Shakaskraal, Vryheid Landbou and Zakhe Agric College).
- * Through the Drought Intervention Programme, the Department intervened with measures and provided animal feed, deworming and hay (7 454 tons of Lucerne and Teff) at the value of R 1,855,535.
- * The Department created 951jobs through EPWP and Land Care projects

Veterinary Services

- * Foot and Mouth Disease initiative, the Department has appointed through IDT Consulting Engineers four contractors with the project value of R76 019 412.00 FMD Redline fencing, 96 kms of fence line erected, together with associated vehicle and pedestrian gates, gravel patrol roads of 98 kms and 30 guard houses are completed.
- * Rabies control vaccinations campaigns have significantly impacted the outbreaks of rabies which has have dropped during the report period 2015/16 from 200 to 38 positive cases.
- * Through the compulsory community service 10 graduates benefited through state veterinary work.
- * The Department has organized the livestock auction sale which generated 13 million for livestock owners within the province.
- * Veterinary Diagnostic Services, the Department through two laboratories i.e. Allerton and Vryheid generated revenue in excess of R1, 5 million.

Research and Development

* Through soil analytic analysis of 29853 samples the department generated revenue in excess of 2, 1 million in the financial year.


Programme 3: Rural Development

Introduction of rural development function within the department required extensive planning and coordination to establish the respective forums and development of frameworks which will set the baseline for implementation. In this regard, the Branch: Rural Development had undertaken the following, but not limited to, initiatives:

- The branch partnered with national to launch the agripark strategy in the province and district level
- The Department coordinated provincial agri-village initiative at Emadlangeni which resulted in the development of coordinated and integrated human and agriculture settlement planning approach
- * The branch established the KZN Interdepartmental Task Teams and held two task team meetings to share and engage in joint planning on outcome 7 strategies
- * Hosted the Female Entrepreneurs Awards, Youth Summit for unemployed graduate and skills training for women farmers.

7. Our budget

The budget allocation to the Department's vote was R2 292 480 000.

At the end of the 2015-16 financial years, the Department had spent R2 199 187 000 of its budget. The under-expenditure of R93 293 000 of the budget allocation was due to the following:

Programme 1: Administration

- R1.646 million as a result of the moratorium on filling posts until the matching and placing
 of existing staff into the new organizational structure is finalized.
- R12.179 million in respect of the migration from Novell to Microsoft not being finalized as anticipated.
- R955 000 relates to the fact that the payment to Public Service SETA did not materialize as this payment is now managed at a national level.

 R15.583 million relates to machinery and equipment, mainly as a result of vehicles ordered but not delivered of R5.023 million, as well as the delay in the migration from Novell to Microsoft resulting in the server not being acquired as planned, amounting to R10.560 million.

Programme 2: Agriculture

- R1.874 million as a result of the moratorium on filling posts until the matching and placing
 of existing staff into the new organizational structure is finalized.
- R10.280 million in respect of animal feed and medicines ordered but not delivered and paid for by 31 March 2016. This includes additional fodder for drought relief to small-scale and subsistence farmers.
- R19.865 million in respect of lower than planned transfers to Communal Estates that were
 established by the consolidation of adjacent parcels of land into viable farming units and
 the establishment of commercial farming operations by the land owners in partnership
 with government due to limited farming activities, as a result of the drought as well as
 slower than anticipated progress on a hatchery project supported by the department.
- R30.799 million under payment for capital assets as a result of slower than anticipated implementation of drought relief interventions such as boreholes, stock watering dams and dip tanks due to high demand and short supply for service providers due to drought amounting to R27.733 million as well as vehicles ordered but not delivered amounting to R3.066 million.

Programme 3: Rural Development

• The under-expenditure of R104 000 is in respect of Compensation of employees and related costs in respect of vacant posts.
