 - recover costs, losses or damages it has incurred or suffered as a result of that person's (b) conduct;
 - cancel the contract and claim any damages which it has suffered as a result of having to make (c) less favourable arrangements due to such cancellation;
 - recommend that the bidder or contractor, its shareholders and directors, or only the (d) shareholders and directors who acted on a fraudulent basis, be restricted by the National Treasury from obtaining business from any organ of state for a period not exceeding 10 years, after the audi alteram partem (hear the other side) rule has been applied, and
 - forward the matter for criminal prosecution. (e)
