 - recommend that the bidder or contractor, its shareholders and directors, or only the (d) shareholders and directors who acted on a fraudulent basis, be restricted by the National Treasury from obtaining business from any organ of state for a period not exceeding 10 years, after the audi alteram partem (hear the other side) rule has been applied; and (e)
 - forward the matter for criminal prosecution.
