TERMS OF REFERENCE FIRE FIGHTING EQUIPMENT AT CEDARA

PROJECT DESCRIPTION

APPOINTMENT OF SERVICE PROVIDER FOR MAINTENANCE, SERVICING AND REPAIRS OF FIRE EQUIPMENT FOR A CONTRACT DURATION OF 3 YEARS FOR THE DEPARTMENT OF AGRICULTURE AND RURAL DEVELOPMENT – HEAD OFFICE, CEDARA

1. BACKGROUND

- 1.1 The Department of Agriculture and Rural Development is a key department within the economic cluster in stimulating growth and job creation, and it remains a kernel in the baseline sustainable economic sectors as well as rural economy, with specific interventions and support to reduce and eliminate poverty through subsistence farming.
- 1.2 The department in its efforts to ensure the safety of staff and clients, as well as compliance to the Occupational Health and Safety Regulations; seeks to appoint a service provider experienced in servicing Fire Fighting Equipment for a period of three years to conduct routing preventative maintenance and repairs at Cedara College, Cedara, Pietermaritzburg.
- 1.3 The Service Provider needs to meet the following requirements: South African Qualification and Certification Committee (SAQCC) registration, SABS Registration in terms of SANS 1475, SANS 1475 Permit current and issued by department of Labour approved accreditation. Letter of good standing order from Workmen's Compensation SANAS approval for CO-2 pressure testing and Membership with FFETA where necessary.



2. SCOPE OF WORK

The scope of work includes annual services and repairs for a period of 3 years. The scope of work below is application to the Fire Extinguishers, Fire Hydrants and Fire Hoses. All the work carried out must be in accordance with NFPA 25 Standard guidelines and the spares used must be SABS approved.

The scope also entails (*as and when needed*):

- Replacement of worn-out fire equipment signs
- Replacement of damaged or corroded hanging hooks for fire equipment.
- Immediate recharge of fire equipment after fire incident
- Immediate refill of used fire equipment
- Provision of weather proof cover for fire equipment located outdoors

2.1 DETAILED SCOPE

Portable Fire Extinguisher Inspection, Service and Testing:

Portable fire extinguishers must be tested to be certain that they are charged and in proper working order, and suitably located according to their potential hazard environment. All fire extinguisher inspections, service, selection and placement, will be conducted annually in compliance with all applicable codes, and each extinguisher use class must be clearly identified, properly positioned, provided noting inspection date, time, and service technician. The last report will also identify equipment type/class or placement discrepancies and officer recommendations, if applicable.

Ensure that each unit is properly hung with the proper manufacturer's hanger. Remove each extinguisher from its hanger, and check:

1. Gauge pressure
2. Condition of gauge and its compatibility with an extinguisher
3. Weight of extinguisher
4. That last hydro-test date is within code requirements
5. Valve and shell for damage or corrosion
6. Hose and inspect it for cracks or splits (remove the hose to inspect closely)
7. Hose threads for signs of wear
8. Condition of discharge horn



9. Check for obstructions that may interfere with access to the extinguisher
10. Additionally, by breaking the extinguisher seal and removing the locking pin
11. Upper and lower handles
12. Replace locking pin and reseal extinguisher
13. Inspect valve opening for powder or any foreign matter
14. For dry extinguishers, fluff the powder by turning the unit
15. Clean extinguisher shell with spray cleaner
16. The return hose to its proper position
17. Check the condition of the hose/horn retention band at the side of the extinguisher
18. Verify that each unit's classification is properly identified with the appropriate decal
19. Check that all operating instructions are clean and legible
20. Properly tag each extinguisher
21. Survey the area around the unit to verify that the unit classification corresponds properly with all potential hazards
22. Verify unit is properly located within normal travel pathways and positioned at a conspicuous and accessible height
23. Ensure unit is visible and unobstructed
24. Replace extinguisher on its hanger
25. Provide a brief written report of the inspection to the customer, detailing and deficiencies

Fire Hydrant and Fire Hose

Remove the hose from its rack, and check:

1. That the last hydro-test date is within requirements of couplings condition of the threads
2. Condition of the gasket in the coupling, replace if necessary
3. Valve for damage, rot, or mildew
4. Hose for damage, rot, or mildew
5. Nozzle for damaged threads and damaged or blocked tip and verify that the standpipe hose threads match the type used by the local Fire Department. If threads do not match, the adapter should be supplied
6. Reattach coupling to the valve
7. Reposition the hose on the rack so that folds do not occur in previous positions

8. Replace nozzle and attach it to the nozzle clip on the rack and tag the unit properly
9. Check the cabinet for easy access and, where applicable, check that the glass is intact
10. Observe the hazard area to confirm that there is sufficient hose to reach any direction
11. Check that the hydrant is visible and unobstructed. If it is obstructed, notify the customer
12. Provide a brief written report of the customer, detailing any deficiencies
13. Ensure the customer is updated with the proper operation of the equipment, as needed

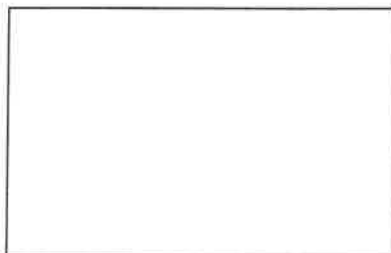
