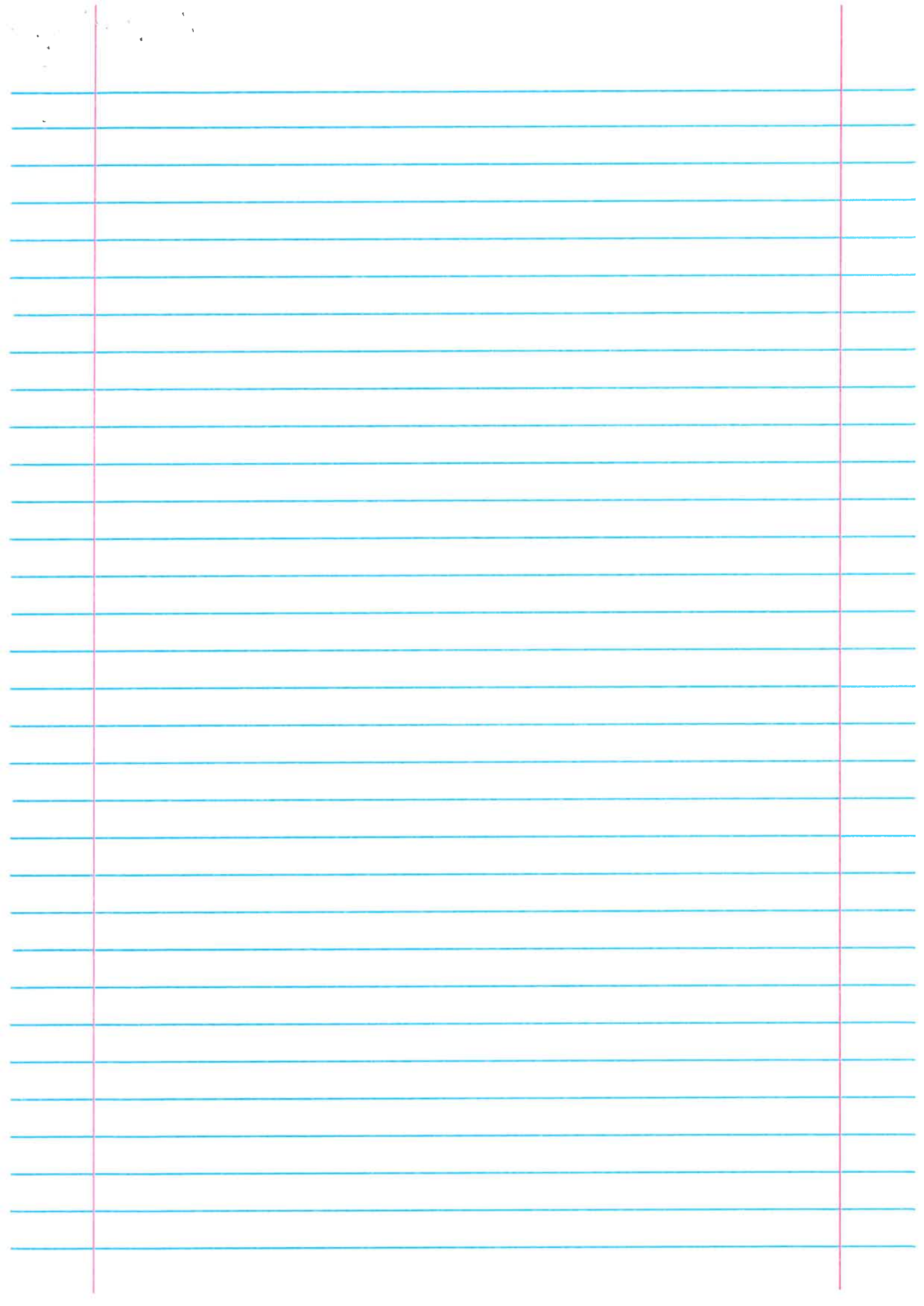

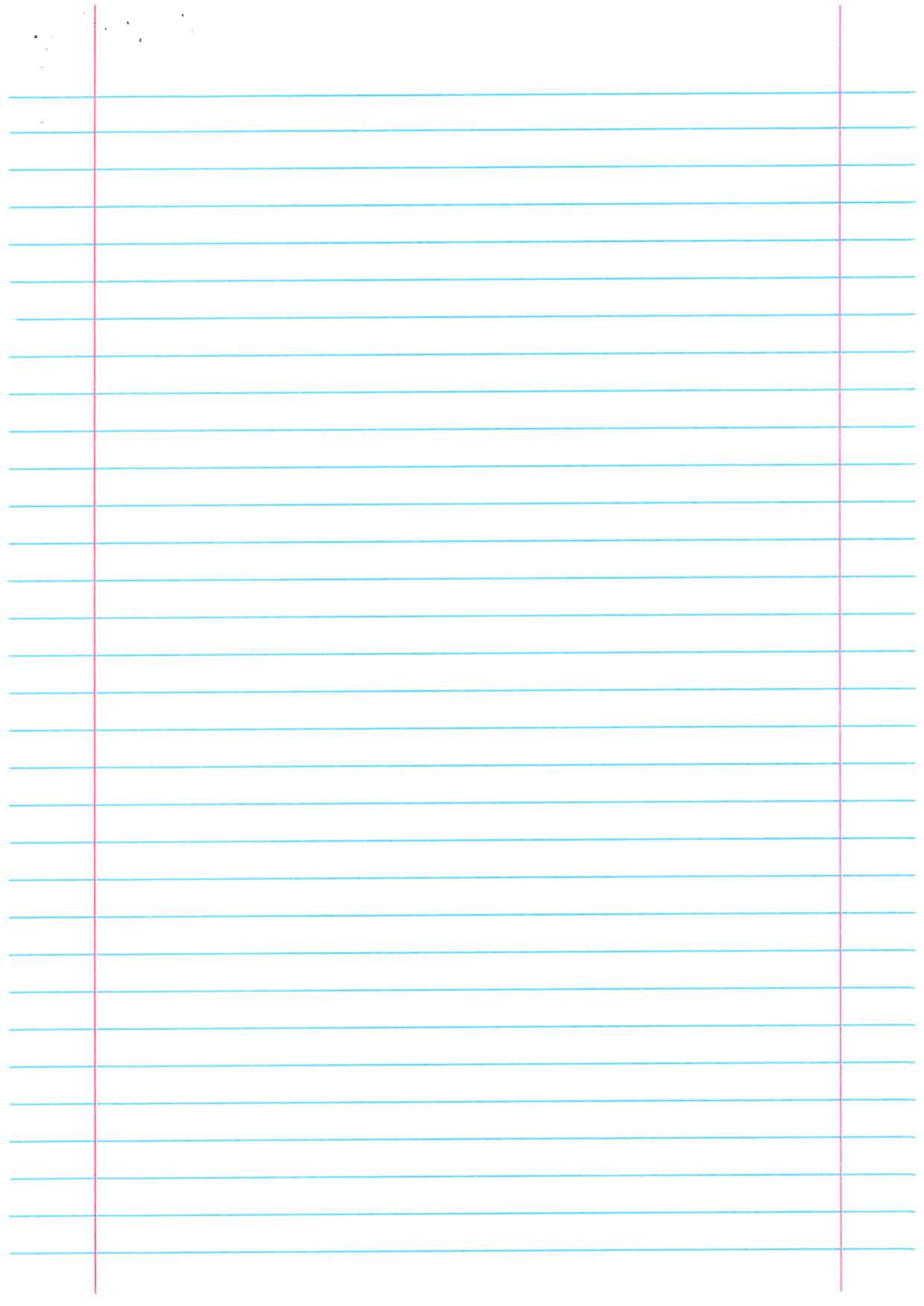
1. The instructions of the invigilator must be obeyed at all times.

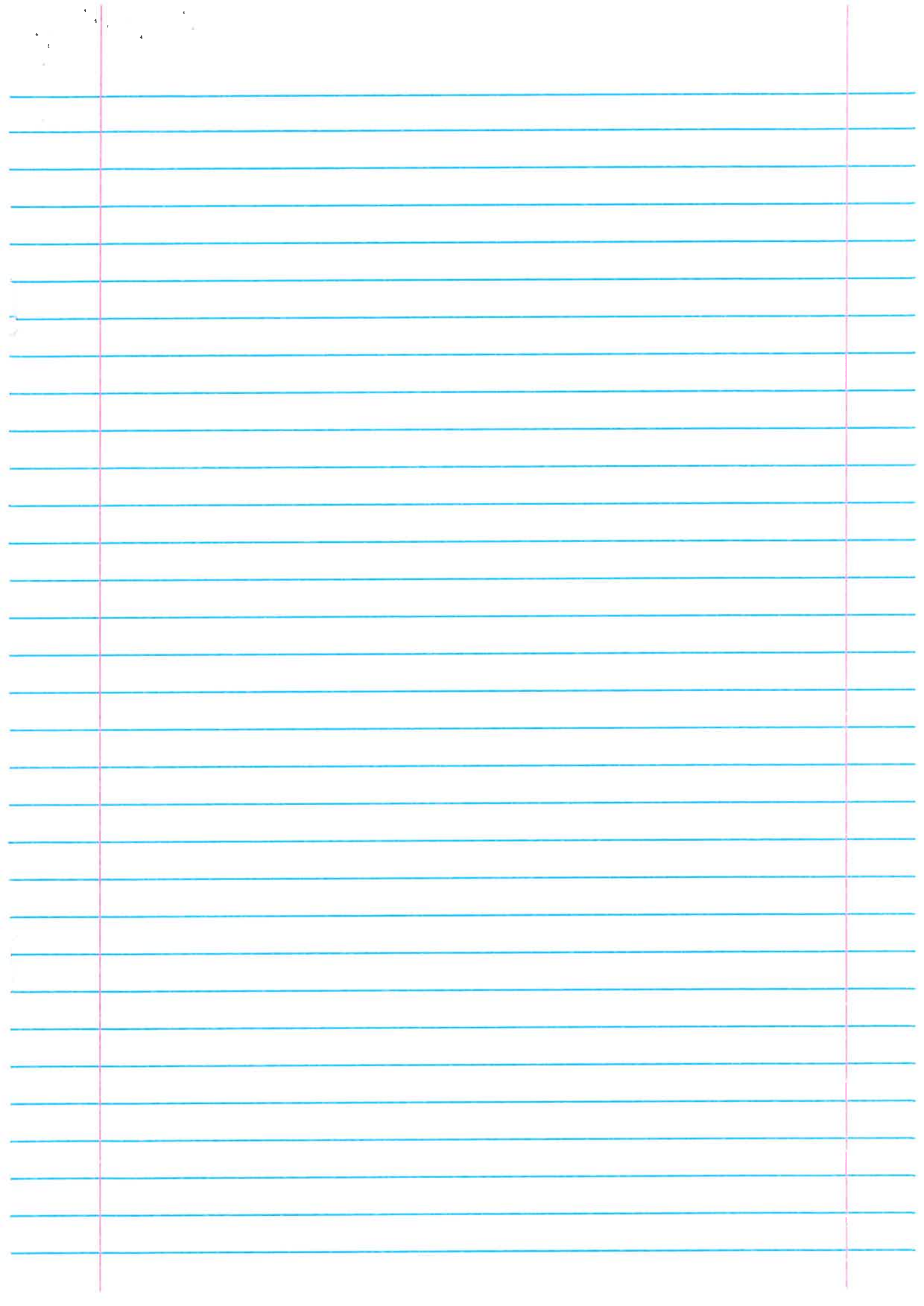

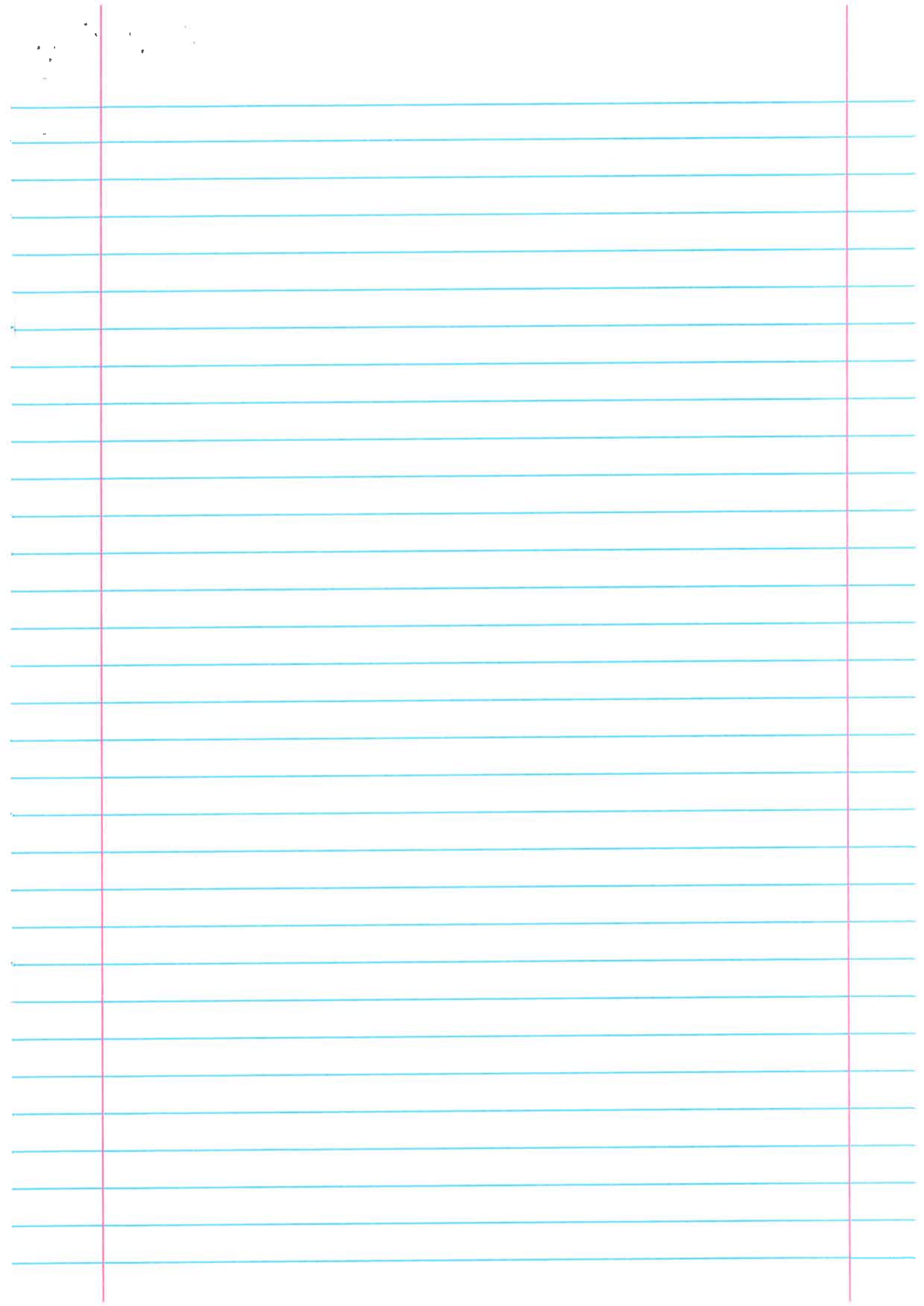
