A TERMS OF REFERENCE

1 EMPLOYERS OBJECTIVES

- 1.1.1 The employer's objective is to conduct rehabilitation works at Madungeni Irrigation Project.
- 1.1.2 The Employer seeks to appoint a suitable and competent Service Provider to conduct the rehabilitation at Madungeni Irrigation Project.
- 1.1.3 The Employer desires that the work required be of a high standard and be completed in the shortest practical time whilst making use of local labour where practical possible.
- 1.1.4 The successful contractor would be required to supply proof of experience required to implement a project of this nature.

2 SCOPE OF WORKS

The purpose of the project is conduct rehabilitation of Madungeni irrigation project approximately 24ha. The irrigation system is existing with some valves, nylomatic and sprinkler heads damaged. Extent and scope of works is as follow

- 2.1.1 Supply, delivery and install the damaged tunnels gables
- 2.1.2 Supply, delivery and install new tunnels flooring including required earthworks
- 2.1.3 Supply, delivery and install the new dosing system with all associated fitting
- 2.1.4 Supply, delivery and install the new tunnel pressure pump with all associated fittings
- 2.1.5 Install the irrigation system and conduct repairs to tunnels plastics and irrigation system-
- 2.1.6 Supply, delivery and install control system for the tunnels

3 PROJECT LOCATION

Madungeni Irrigation project falls within Harry Gwala District Municipality in KwaZulu Natal. The project is located approximately 25km South East of Ixopo Town. The project is located in the following coordinates 30°20'30.83"S; 30°04'21.25"E.

4 COMPETENCY OF THE SERVICE PROVIDER

- 4.1 This bid is open for contractors with a Construction Industry Development Board (CIDB) data base grading of a **minimum of 1SH/1CE or higher**. The contractor is to submit evidence of his/her OWN **Active** registration.
- 4.2 For evaluation processes, the Department shall apply the evaluation criteria as outlined in the Bid Evaluation Criteria of this bid.
- 4.3 It shall be vital for the appointed supplier to have sufficient financial resources and capacity to finance and execute as per terms and conditions of the contract.

5 COMPULSORY SITE BRIEFING

5.1 A compulsory site-briefing meeting will be held with prospective Bidders. Attendance at the meeting will be compulsory and non-attendance shall invalidate any bid. The date and time of the meeting will be published in the Bid Advertisement or, in the case of a quote, be communicated when the prospective service provider is invited to quote.

6 PERIOD OF CONTRACT

6.1 The contract to be implemented in **two (2)** calendar month effective from the site handing over date to the contractor.

7 COMMENCEMENT OF THE WORK

- 7.1 Site establishment must start within one (1) week, and the actual works within two weeks after hand-over of the site, provided that;
- 7.1.1 An official order has been issued:
- 7.1.2 The contractor is in possession of all relevant documentation required for works execution;
- 7.1.3 No exceptional circumstances such as inclement weather or other outside the control of either party to the contract prevail.
- 7.2 In case work has not commenced within two (2) weeks of the site hand-over and no attenuating circumstances for the delay can be provided, the Department reserves itself the right to cancel the contract.

8 HANDOVER OF SITE TO CONTRACTOR

- 8.1 The Department will organize a site hand-over to the contractor who will then be introduced to the project stakeholders and participants. The site handover will be the official start of the construction period, and the work will have to be completed within the period stipulated in clause 59 ("Completion period and rate of progress")
- 8.2 The site will be handed back at works completion after a final inspection by the Engineer revealed no outstanding patent defects.
- 8.3 The Contractor will control the site for the contract duration. Only the Contractor's own employees, Contractor's local labour and Departmental Representatives will be allowed on site.
- 8.4 The Contractor is responsible in the administration, control and security on the site at all times during the contract duration.

9 WATER AND POWER

9.1 The Contractor shall make the necessary arrangements for the provision of any water and power. No payment will be made for the provision or use of these services and the cost of these shall be included in the Bid/quoted amount.

10 LOCATION OF CAMP

- 10.1 The Contractor's camp may be erected on the site of the works but must meet the approval of the Engineer, project beneficiaries and landowners.
- 10.2 No persons other than a night watchman may sleep in the camp, without the approval of the local relevant Stakeholder.

11 HOUSING OF CONTRACTOR'S EMPLOYEES

- 11.1 The Contractor shall make his own arrangement for housing, payment and feeding his employees and transporting them to and from the site. However, it may be possible to arrange temporary local accommodation for the Contractor's staff with the participants.
- 11.2 The Contractor is in all respects responsible for the housing and transporting of his employees, and for the arrangement thereof, and no extension of time due to any delays resulting from this, will be granted.

12 LABOUR SOURCE & CAPACITY

- 12.1 The Contractor will be required to satisfy the Department that a sufficient and experienced labour force is employed or that sufficient experienced labour can be acquired to complete the services and produce an acceptable quality of workmanship.
- 12.2 The contractor is encouraged to source unskilled labour from the project participants or local community. The Contractor and the Departmental representative (Engineer or local Agricultural adviser) may negotiate with the participants in this regard to establish all the conditions for the utilization of the local labour.
- 12.3 The Contractor will be responsible for all hiring, payment, housing and transport of all labour used for the duration of the contract.

13 SECURITY & RISK

- 13.1 No one shall be allowed on the construction site after normal working hours except for the necessary security personnel.
- 13.2 The Contractor shall also be responsible for safeguarding all plants, machinery, equipment and materials on site. The Engineer shall not be responsible for any lost, damaged or stolen property or materials. Should any of these situations arise, no allocations will be made in terms of finances or time.

14 MATERIALS: DELIVERY, ON & OFF-LOADING, STORAGE & RESPONSIBILITY

- 14.1 The Contractor shall be responsible for the safe delivery, loading, off-loading, handling and storage of any equipment and materials on site.
- 14.2 All equipment, materials and plant stored on site must be suitably protected against damage or loss by theft or otherwise.
- 14.3 The Contractor shall remain fully responsible for all material and plant etc. until the completed works are handed over and have been officially accepted by the Department.

15 EXISTING ROADS, MUNICIPAL PAVEMENTS, ETC.

15.1 The Contractor is advised that he will be held responsible for any damage to the existing pavings, roads, municipal pavements, fences, boundary walls, etc., and will have to repair such damage at his expense

16 DAMAGE TO PROPERTY

16.1 If the Contractor or his/her employees, while engaged in the execution of the contract, shall break, deface, injure, destroy or allow to fall into disrepair any part of the Works or property belonging to the Department, or any private property including: buildings, paving, roads, fences, walls or grounds contiguous to the premises of the Department on which he or they may be employed, the Contractor will be required to repair, in a perfect and workmanlike manner, at own expense all damage to the approval of the Department. The Completion Certificate will not be issued until the Department is satisfied that all necessary remedial work has been satisfactorily completed

16.2 The Contractor shall take every precaution against damage or nuisance being caused by dust both to the properties of the Employer and all surrounding properties and shall indemnify the Employer against any claim that might arise there from.

17 UNDERGROUND CABLES AND PIPES

- 17.1 If such services are discovered, immediate notification must be made to the Employer and all work in the vicinity of such cables, pipes, etc., shall cease until safe to proceed.
- 17.2 Should the Contractor damage underground cable or pipes, such damage shall be repaired as soon and safely as possible by the Contractor.
- 17.3 The cost of making good such damage will be met by the Contractor as this must be covered by the Contractors works insurance.

18 DAILY RAINFALL RECORDS

18.1 Submission of rainfall figures is required for the granting of permission of extending the contract period on the basis of inclement weather. If none are kept, the Engineer is under no obligation to grant extension of the completion period for inclement weather.

19 INSPECTION OF WORK

- 19.1 The Departmental representative may at all reasonable times have access to the site where work is being executed for inspection purposes.
- 19.2 The Engineer may request that evidence of the quality or strength of any materials be supplied by the contractor wherever necessary.

20 NOTICE OF COVERING WORK

- 20.1 The Contractor shall give due notice to the engineer whenever any work or materials are intended to be covered in with earth or otherwise in order that their correct dimensions and quality may be ascertained before being covered.
- 20.2 If any such work or materials are covered without such notice having been given, the work or materials shall be uncovered at the Contractor's expense on instructions given by the Engineer.

21 INSURANCE

- 21.1 All accepted approved contractors would be required to provide the following insurances for the project awarded to them:
- 21.1.1 Insurance against damage, destruction or loss to 50% of the value of the contract.
- 21.1.2 Public Liability insurance.
- 21.1.3 All risks (works) policy and Political.

22 SUB-CONTRACTED WORK

- 22.1 The contractor shall not sub-contract the entire contract.
- 22.2 Sub- contracting shall not relieve the contractor from any liability or obligation under the contract and she/he shall be liable for the acts, defaults and neglects of any sub-contractor, his/her agent or employees as fully as if they were the acts, defaults or neglects of the contractor.

23 PROTECTION OF THE PUBLIC

- 23.1 Bidders including those sub-contractors and/or suppliers who are preparing prices/quotations for submission to the main bidder) must ensure that they make adequate financial provision in their bids for full compliance with the Occupational Health and Safety Act (85/1993): Construction Regulations, 2014, as published in the Government Gazette of 7 February 2014, or later amendments thereto. Financial provision shall therefore be made by each Bidder for, inter alia, the following:
 - Carrying out and documenting risk assessments of all work to be carried out under the contract.
 - · Preparation of safe work procedures.
 - Preparation of an H&S plan, discussing it with the Department, and then amending it as agreed.
 - · Regular updating of all of the foregoing.
 - Provision of medical certificates of employees.
 - Provision of PPE and protective clothing for employees
 - Complying with all H&S requirements for the duration of the contract.
 - Provision of forced ventilation (as required when working in confined spaces).
 - The completion and checking of the safety file upon completion of the works and handing it over to the Department.
- 23.2 To enable the Department to appraise the allowances that Bidders have made for H&S in their bids, so that he/she can fulfil his/her obligations in terms of Clause 7 of the Construction Regulations, separate items have been included in the Bill of Quantities for Health and Safety.
- 23.3 Failure to submit realistic prices for the scheduled H&S items is likely to prejudice the bid.
- 23.4 The Contractors must submit proof of compliance with the OHS requirements.

24 DISAGREEMENTS

- 24.1 <u>Notice of disagreement.</u> The Contractor has the right by written notice to the Engineer to require him to consider any disagreement which he raises with the Engineer provided the said written notice shall be given within 14 days after the cause of disagreement has arisen.
- 24.2 <u>Ruling on disagreements.</u> The Engineer shall give a ruling on the disagreement in writing to the Contractor no later than 14 days after his receipt of a written request from the Contractor requiring him to do so. The Engineer shall provide such a ruling with as little delay as possible. During the response time the Contractor shall not alter the status of the works under contention.

25 INJURY TO PERSONS

25.1 The Contractor shall be liable for and shall indemnify the department in respect of any liability, loss, claim or proceedings whatsoever, whether arising in Common Law or by Statute in respect of personal injuries to or death of any person whomsoever arising out of or in the course of or caused by the execution of the Works

26 QUANTITIES OF WORK

26.1 The Contractor shall receive payment only for the works actually executed and approved by the Engineer.

27 PROGRESS PAYMENTS

- 27.1 Payment shall only be made for claims that are commensurate with the works actually executed and complete.
- 27.2 Payment will only be made against the construction progress as pertaining to **built /installed** items. Movable items and materials on site are generally excluded from progress payments until they have been fully installed or fitted or built up.
- 27.3 If any item or part of an item in an invoice is disputed, the Engineer shall give notice to the contractor explaining the disputed item and request for re-measurement.
- **27.4** Part payments will be made after the Engineer has approved the work and will be made in accordance with the Retention clause (58).
- **27.5** The penultimate payment occurs after <u>practical works completion</u>. The final payment will be made after the **3 months** liability period when the contractor has dealt with all defects, if any.

28 COMPLETION OF THE WORKS

- 28.1 Work completion will be established over three stages.
- 28.1.1 Practical completion This is defined as the stage when the works are found to be substantially complete and can be used for the purposes intended. This assessment will be solely made by the Engineer. When the Contractor thinks he has completed the works, an inspection will be made by the Engineer who will draw up a list of patent defects, commonly known as a "snag list", if any. Patent defects are defects that are visible or discoverable upon an ordinary and proper inspection.
- 28.1.2 <u>Works completion</u> This stage will be reached after the Contractor has, to the sole assessment of the Engineer, fixed all defects listed on the snag list. It is at works completion that the Contractor will be paid out 50% of his/her retention money.
- 28.1.3 *Final completion* Final Completion occurs **3 months** after Works completion, after expiry of the liability period.

29 RETENTION

- 29.1 A 10% retention will be withheld on payment for duration of the construction.
- 29.2 The Department will pay out half of this retention, or 5% of the bid value as part of the second last payment at **works completion** of the works. The remainder, *viz* 5%, will be paid out at **final completion** after expiry of the defect liability period 12 months after practical completion), the bidder having eliminated all defects.
- 29.3 In some instances, the Engineer may decide to shorten this period in order to allow all payments to be completed within the financial year. However, this is **not** a given and the Contractor will be notified during the course of the construction if such would be the case.

30 DEFECT LIABILITY PERIOD

- 30.1 The defect liability period is **3 calendar months** calculated from the date of works Completion.
- 51.1. The contractor shall unconditionally guarantee all materials, workmanship related to the works for that period. The guarantee shall cover any defects due to inferior materials and/or workmanship of the Contractor, or any of his sub-contractors, fair wear and tear excepted. The Contractor shall repair, remedy or replace any such defects, part or complete works without delay and at his own cost.

31 CONTINGENCIES

31.1 An amount of 10% of the subtotal for all materials, equipment and services has been set aside for Contingencies. This allowance will only be accessed for unforeseen additional expenditure not covered in the contract. Such approval must be in line with SCM Delegations.

32 PERIOD OF COMPLETION & RATE OF PROGRESS

- 32.1 The project has to reach practical completion within 2 calendar month of award of the contract (60 calendar days)
- 32.2 If the Works are delayed by any cause beyond the Contractor's control, the Contractor shall have the right within twenty-one days of any such cause of delay arising, to apply in writing to the Department to extend the date of completion, stating the cause of delay and period of extension applied for.
- 32.3 The Department upon receipt of such written application may by order in writing extend such date of completion by a period to be determined, or may refuse to extend such date of completion, or may postpone giving a decision upon such application until completion of the Contract period set out in sub-clause (1) of this clause.
- 32.4 The date of completion will be extended only to the extent approved by the Department.
- 32.5 Should the Contractor fail to apply in writing for an extension within the time set out above, or should the Department refuse to grant any extension in writing, then the Contract period provided shall not be exceeded.
- 32.6 When the Works are completed the Department will give a completion certificate and the date of such certificate shall be the date of commencement of the guarantee period.

33 PENALTY CLAUSE / FINES FOR LATE OR NON-COMPLETION

- 33.1 If the contractor does not complete the work within the time stipulated and no extenuating circumstances can be given for the delay, the Department may impose a fine as detailed below. The total will be subtracted from the retention allowance.
- 33.2 If the contractor fails to complete the works and the Department is forced to employ another contractor to complete the works, the defaulting contractor will be held liable for the costs as far they exceed the original total Bid value.
- 33.3 The department will deduct a penalty for late completion of up to 0.05% of the contract value per working day delay. This will be deducted from the retention.

B. SPECIAL TERMS & CONDITIONS

1 INTRODUCTION

- 1.1 Bidders must ensure that they are fully aware of all the Terms and Conditions contained in this bid document. Only bidders that fully meet the prequalification shall be considered.
- 1.2 The Bidder is required to check the number of consecutively numbered pages. Should any found to be missing or in duplicate, or the text of figures indistinct, or should there be any doubt or obscurity as to the meaning of any part of these documents, the Bidder must ascertain the true meaning or intent of the same prior to the submission of his/her Bid. No claims arising from any incorrect interpretation will be admitted.

2 ACCEPTANCE OF BID

2.1 The Department is under no obligation to accept any bid.

3 AMENDMENT OF CONTRACT

3.1 Any amendment to or renunciation of the provisions of the contract shall at all times be done in writing and shall be signed by both parties, subject to the Department approval.

4 AWARD

- 4.1 All bids received shall be evaluated on the following phases of evaluation:
 - (i) Stage one: Administrative Compliance
 - (ii) Stage two: Price and Specific Goals

5 BASIS OF QUANTITIES

5.1 Quantities are as reflected on the Bill of Quantities as attached as the annexure.

6 CHANGE OF ADDRESS

6.1 Bidders must advise the Departmental Supply Chain Management, Contract Administration should their ownership or address (domicilium citandi et executandi) details change from the time of bidding to the expiry of the contract.

7 COUNTER OFFERS

7.1 Counter offers shall not be considered.

8 DELIVERY CONDITIONS

- 8.1 Delivery of services must be made in accordance with the instructions appearing on the official purchase order.
- 8.2 All deliveries or dispatches must be accompanied by a delivery note stating the official purchase order number against the delivery that has been affected.
- 8.3 In respect of items awarded to them, contractors must adhere strictly to the delivery periods stipulated by them in their bid document.

- 8.4 The instructions appearing on the official purchase order form regarding the supply, dispatch and submission of invoices must be strictly adhered to.
- 8.5 All invoices submitted must be original.
- 8.6 Deliveries not complying with the order form shall be returned to the contractor at the contractor's expense.
- 8.7 No locally manufactured product may be substituted during the contract period with an imported product, and vice versa, without prior approval of the Department.

10.1 If two or more bidders score equal total points on price and specific goals in all respects, the award shall be decided by the drawing of lots.

11 FIXED PRICE CONTRACT

11.1 The contract shall **not** be subject to contract price adjustment.

12 IRREGULARITIES

12.1 Companies are encouraged to advise the Department timeously of any possible irregularities which might come to their notice in connection with this or other contracts.

13 LATE BIDS

- 13.1 Bids are late if they are received at the address indicated in the bid documents after the closing date and time.
- 13.2 A late bid shall not be considered and, where practical, shall be returned unopened to the Bidder, accompanied by an explanation

14 INVOICES

- 14.1 All invoices submitted by the Contractor must be Tax Invoices indicating quantity ordered and quantity delivered, the amount of tax charged and the total invoice amount.
- 14.2 A tax invoice shall be in the currency of the Republic of South Africa and shall contain the following particulars:
- 14.2.1 The name, address and registration number of the supplier;
- 14.2.2 The name and address of the recipient;
- 14.2.3 An individual serialized number and the date upon which the tax invoice is issued;
- 14.2.4 A description of the goods or services supplied;
- 14.2.5 The quantity or volume of the goods or services supplied;
- 14.2.6 The value of the supply, the amount of tax charged and the consideration for the supply; or
- 14.2.7 Where the amount of tax charged is calculated by applying the tax fraction to the consideration for the supply and either the amount of the tax charged, or a statement that it includes a charge in respect of the tax and the rate at which the tax was charged.

15 NOTIFICATION OF AWARD OF BID

- 18.2 The same replacement obligation to the Contractor would apply during the construction phase.
- 18.3 In the case of sustained or repeated non-adherence to the specifications of the materials and/or equipment, as well as in the case of general negligence during the implementation process, the contract may be cancelled. The Department will in such cases seek compensation from the contractor for the estimated costs for completion.

- 19.2 The Special Terms and Conditions are supplementary to that of the General Conditions of Contract. Where, however, the Special Terms and Conditions are in conflict with the General Conditions of Contract, the Special Terms and Conditions shall prevail.

20 SUPPLIERS DATABASE REGISTRATION

- 20.1 A bidder submitting an offer must be registered on the Central Suppliers Database at National Treasury. A bidder who has submitted an offer and is not registered on the Central Suppliers Database shall not be considered at the time of award. No pending registrations shall be considered.
- 20.2 A Joint Venture/Consortium must be registered on the Central Suppliers Database at the time of submitting the bid.
- 20.3 NB: If a bidder is found to be employed by the State and is on the Central Suppliers database, the bidder shall be disqualified.

21 TAX AND DUTIES

21.1 During quotation stage, prices offered and paid must include all customs, excise and import duties, and any other tariffs or taxes levied by the government or statutory body having jurisdiction on the goods provided under this contract, including Value Added Tax (applicable at the current rate).

22 TAX COMPLIANCE PIN

- 22.1 The bidder must submit a valid Tax Compliance Pin with the bid. Bidders should note that their tax compliance status shall be verified through the Central Supplier Database and SARS.
- 22.2 Where a Tax Compliance Pin is not submitted with the bid, the Department shall use the Central Supplier Database to verify the tax matters of the bidder.

23 UNSATISFACTORY PERFORMANCE

- 23.1 Unsatisfactory performance occurs when performance is not in accordance with the contract conditions.
- 23.2 The Departmental official shall warn the contractor in writing that action shall be taken in accordance with the contract conditions unless the contractor complies with the contract conditions and delivers satisfactory supplies or services within a specified reasonable time (7 days minimum).
- 23.3 If the Contractor fails to commence the Works or to proceed with and complete the Works in compliance with the projected timeframes, the Head of Department or his/her representative

- shall take action in terms of its his/her delegated powers and adopt and exercise one of the following courses wholly or partly, viz: -
- 23.3.1 To direct the Contractor, in writing, on any day named therein to suspend and discontinue the execution of the Works, and to withdraw himself and his workmen from the said Site or Sites.
- 23.3.2 To make a recommendation to the Accounting Officer for cancellation of the contract concerned.
- 23.3.3 To Contract or Contracts by calling for Bids or otherwise with any other Contractor or Contractors for the completion of the Works, or any part thereof, at such times and upon such terms as to the Department shall deem best.
- 23.4 In relation to the foregoing provisions the Department shall charge any sums of money which may be paid by the Department for completing the said Contract against the Contractor and if such amount shall exceed this Contract, then the Department shall have the right to recover such excess or any balance thereof from the Contractor by legal proceedings.
- 23.5 When correspondence is addressed to the contractor, reference shall be made to the contract number/ item number/s and an explanation of the complaint.

24 VALUE ADDED TAX (VAT)

- 24.1 Bid prices must be inclusive of 15% VAT.
- 24.2 Bidders who make taxable supplies in excess of R1 million in any 12-month consecutive period are liable for compulsory VAT registration, but a person may also choose to register voluntarily provided that the minimum threshold of R50 000 (as of 1 March 2010) has been exceeded in the past 12-month period. Bidders who meet the above requirement must register as VAT vendors, if successful, within one month of award of the bid.
- 24.3 For the purposes of calculating preference points, VAT shall not be considered during quotation process.
