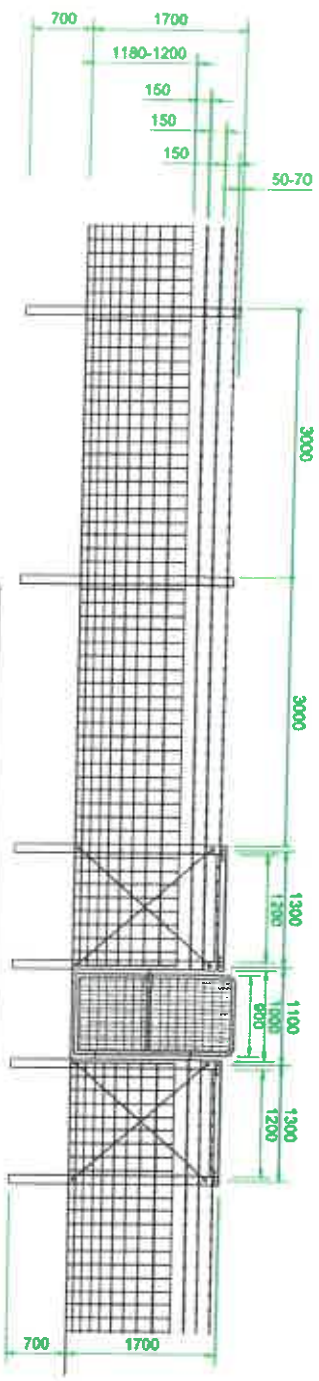

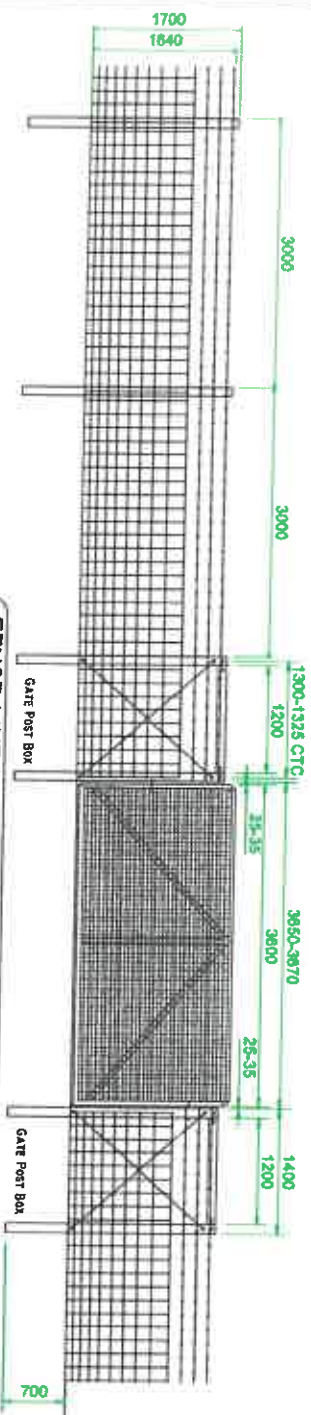

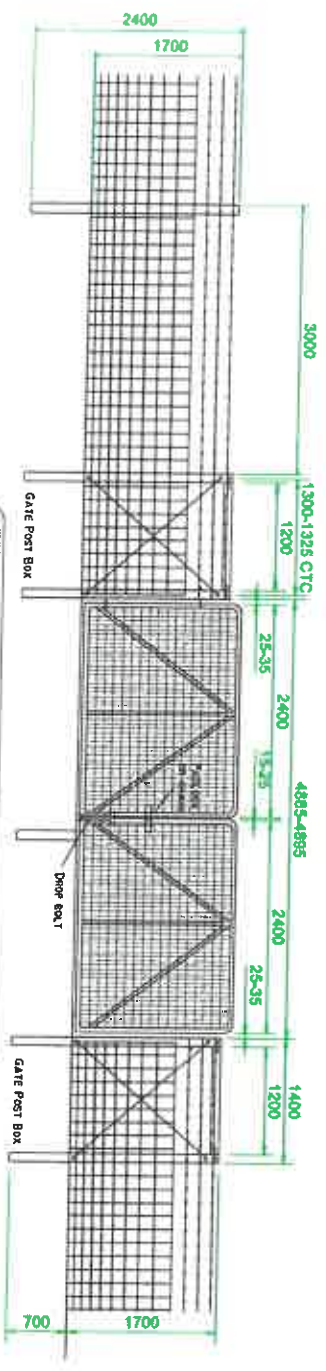




FENCE LINE WITH PEDESTRIAN GATE



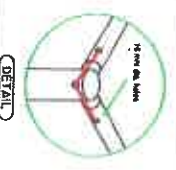
FENCE LINE WITH SINGLE VEHICLE GATE



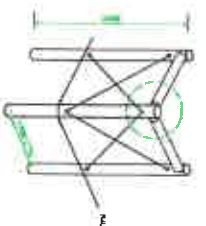
FENCE LINE WITH DOUBLE TRACTOR GATE

NOTES

- 1) ALL Poles pressure treated creosoted (NOT PAINTED ON), 2.4m x 100 -125mm DIAMETER.
- 2) HINGED JOINT FENCING: 1.2m HEIGHT, VERTICAL WIRES SPACED 150mm, HORIZONTAL WIRES - 10 STRANDS, SPACED CLOSER AT THE BOTTOM.
- 3) THREE STRANDS OF BARBED WIRE ABOVE THE HINGED JOINT FENCE 150mm APART.
- 4) BARBED WIRE GALVANIZED, 1.6mm DIAMETER, DOUBLE STRAND - 84.5m ROLL.
- 5) THE FENCE SHOULD BE SECURED ONTO THE HARDWOOD POSTS AND BOXES BY MEANS OF 3.15 x 32 mm STAPLES.
- 6) THE STAPLES ARE TO BE INSTALLED OVER THE HORIZONTAL WIRES AT A 45 DEGREE ANGLE.

- 14) USE WIRE STRAINER FOR TIGHTENING OF STRANDS. ANCHOR END OF WIRE ON BOX BEFORE STRAINING.

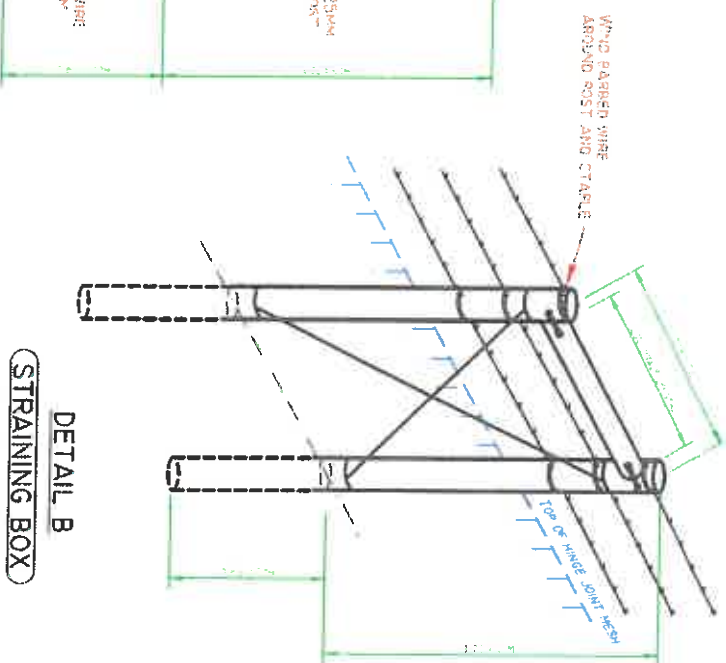
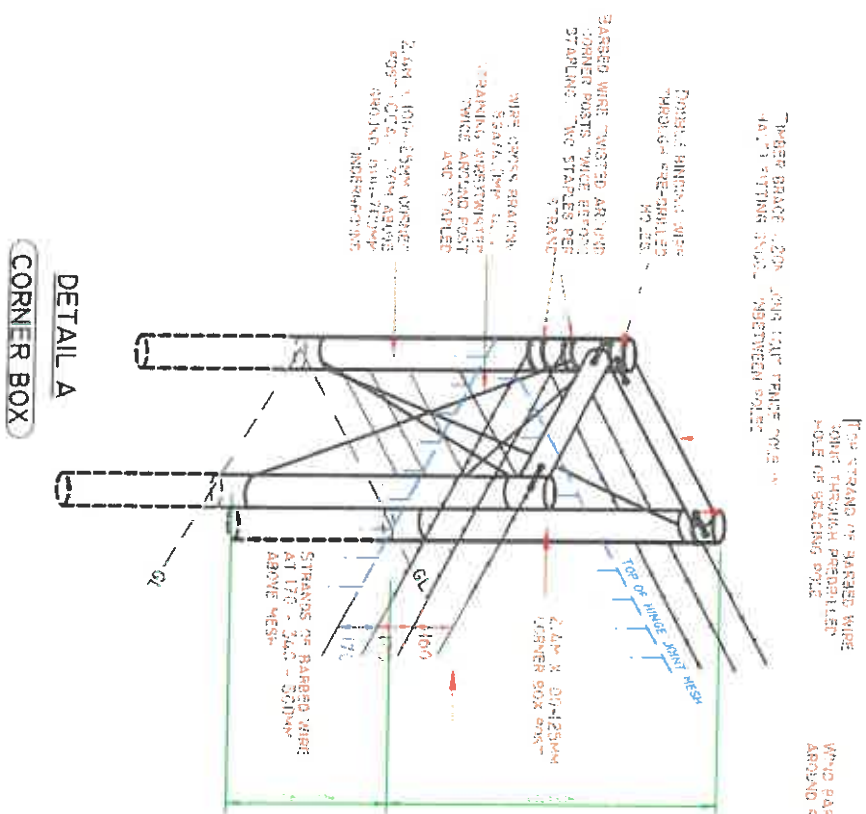

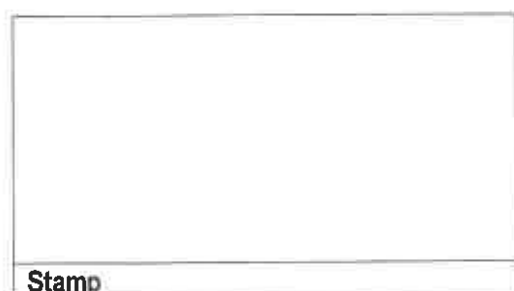
