1 EMPLOYERS OBJECTIVES

1.1.1 The Employer seeks to appoint a suitable and competent Service Provider to transport tractors and implements within uMzinyathi, Amajuba and Zululand District Municipality.

2 SCOPE OF WORKS

The contract covers the transportation and delivery of tractors and implements. The following scope of works applies:

- Hiring of 2 x 32ton lowbed transporters.
- Provision of 2 x drivers with Code 14 (EC) and PDP documents.
- Good in transit insurance for transporting of goods up to R1 million.
- Accommodation of 2 x drivers for the duration of the contract.

3 PROJECT LOCATION

The transportation of tractors and implements is within uMzinyathi, Amajuba and Zululand District Municipality.

4 SPECIFICATION

2 x 32ton lowbed transporter with drivers

The rate to include fuel, permit, insurances and accommodation of drivers.

The rate covers loaded and unloaded and be paid at a kilometre rate.
