APPOINTMENT OF FORENSIC INVESTIGATORS

1. INTRODUCTION

- 1.1. The Department of Agriculture and Rural Development (Department) requests proposals from suitable service providers/consultants to assist the Department in investigating in respect of alleged corruption reported anonymously by the whistle blower at Amajuba District.
- 1.2. The Department of Agriculture and Rural Development (KZN) hereby seeks to engage the skills of an expert to investigate these allegations and to provide a detailed report together with all supporting evidence forming the basis of its findings.

2. BACKGROUND

- 2.1. Department has received an email detailing allegation of corruption that involves the Departments' Officials that are responsible for implementing Mechanisation Services and the Service Providers appointed by the Department to perform Mechanisation in Amajuba and uThukela Districts an. It is alleged that:
- 2.2. The Service provider does not have any assets to carry operations for ploughing, discing, spraying and planting in both districts.
- 2.3. The Service provider belongs to the Head of Department and is using an individual as fronting.
- 2.4. The management of the districts is claiming for hectares that they have not done on site.
- 2.5. The first claim of the service provider for aMajuba district for November 2024 was without doing proper job on the ground.

- 2.6. The Acting District Director at aMajuba has instructed Newcastle and Dannhauser local offices to surrender all hectares they need to plant to eMadlangeni local office.
- 2.7. The service provider is subcontracting in both districts.
- 2.8. Furthermore, the department received a whistle blowing that a transport officer of the Department has his own workshop and is committing fraud by taking kick backs from merchants and has his own workshop that he is sending work to.
- 2.9. The Department also received a whistle blowing from a service provider that was selected to assist in a Direct Funded in project in Utrecht where he didn't receive payments of the last two invoices. It is alleged that the Departmental Officials instructed the change of the banking details of the supplier of a direct funded project which resulted in the two payment not paid to the supplier.

3. DISCUSSION

- 3.1. Internal Control Section conducted a verification of the mechanisation services conducted by the Service Provider in November 2024 at aMajuba and uThukela Districts and the following red flags were established:
- 3.2. There is non-compliance with the Service Level agreement by the Contracted Service Provider since all the work was done by the farmers with their own equipment.
- 3.3. There was no consent to subcontract that was obtained from the Department.
- 3.4. Service provider did not do the actual mechanisation services and was not part of any work done within the Districts.
- 3.5. The farmers with capacity to perform Mechanization in their own farms are part of the farmers that the service provider is claiming to have done mechanization for although they did the service themselves.
- 3.6. There are Hectares that are part of the invoice claimed by the Service Provider of which the verification found to have not been actually done.
- 3.7. There are claimed Hectares are different from Hectares verified.
- 3.8. The service provider alleges that two invoices were not paid by two Departmental Officials one is an engineer and the other is a project director. These payments were not paid to the Service provider's account but to a different bank account on instruction of the two employees. It is alleged that the Departmental officials instructed the change of the banking details.

4. SPECIFIC OBJECTIVES

The objectives of this investigation are the following:

- 4.1. Whether the service Provider contracted mechanisation services to the local business or to farmers that are also beneficiaries.
- 4.2. To investigate if the service provider solely relies on the report from the Departmental officials to sign forms for the payment process without physical monitoring the project or being on site.
- 4.3. Whether Amajuba District approached the farmers who had already done the planting to be claim from the Department as beneficiaries.
- 4.4. To investigate if there is allocation of Hectares to farmers that applied for Mechanisation Services.
- 4.5. To establish how the Service Provider, monitors the work that he provides to the District Offices.
- 4.6. To investigate if all the alleged contracted farmers were appropriately paid by the Service Provider and what rate was used.
- 4.7. Processes followed by Departmental officials to assist farmers for mechanisation.
- 4.8. Who appointed the alleged contracted local people to perform Mechanisation for local farmers.
- 4.9. How fields are measured by extension officers and Service Provider for the purposes of making invoice to claim for services provided.
- 4.10. If there is a transport officer in the Department that has his own workshop.
- 4.11. Establish any fraud committed by the transport officer on the Department's vehicles being repaired.
- 4.12. Establish if the service provider assisted in the direct funded project in Utrecht.
- 4.13. Did the service provider receive all the payments that were due as per the work quoted and agreed upon and if the banking details were changed.
- 4.14. If not establish if there was any corruption that took place.

Consequent to the investigation the service provider should compile a detailed and comprehensive report that inter alia identifies irregularities that have occurred, the officials, and/or other person/s responsible for such occurrence, provide recommendations on the remedial action to be taken as well as advise on the internal control processes to be strengthened.

5. SCOPE OF SERVICES

- 5.1. The service provider/consultant shall obtain all relevant documents, statements/affidavits and other information necessary for this investigation.
- 5.2. All three (3) investigations shall be completed and finalized, within the period of three (3) months from the appointment date.
